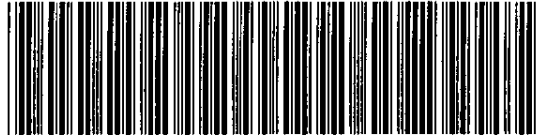

ARTICLES OF INCORPORATION

OF

(A Non-Profit Corporation)

The undersigned, acting as incorporator, for the purpose of forming a corporation for charitable and philanthropic purposes, pursuant to Chapter 617 of the Florida Statutes, under the Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME & PRINCIPAL OFFICE

The name of the corporation shall be **MY Community Center, Inc.**, and it shall have a principal address of 5101 N Apopka Vineland Rd., Orlando, FL 32818.

ARTICLE II TERM OF EXISTENCE

The corporation shall exist perpetually, commencing on the date these Articles are filed with the Florida Secretary of State, and to be effective December 1, 2008.

ARTICLE III PURPOSE(S)

This corporation is formed exclusively for the charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and to that end, to do the following:

- a. Put Islamic principles into practice by providing a community center that build spirit mind and body for all.
- b. To the extent permitted by law to exercise its rights, power and privileges, to hold meetings of its Board of Trustees, to have one or more officers and to keep the books of the corporation
- c. To do any and all lawful acts and things, alone or in cooperation with other persons or organizations, which may be necessary, useful, suitable or proper for the furtherance, accomplishment, or attainment of any or all of the purposes or powers of the corporation.

ARTICLE V BOARD OF TRUSTEES

Section 1. The business affairs of this corporation shall be managed by the Board of Trustees. This corporation shall initially have five (5) Trustees. The Trustees shall be elected by votes based on credentials and experience. There shall be no fewer than three (3) trustees at any given time.

ARTICLE VII USE OF INCOME

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or to private individuals, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution incurred for the benefit of the corporation

ARTICLE VIII PROHIBITED ACTIVITIES

Section 1. No substantial part of the activities of the corporation shall be the carrying on of any propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office

Section 2. Notwithstanding any other provision of these articles, this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation

ARTICLE IX DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Service Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. None of the assets shall be distributed to any member, officer, or trustee of this corporation.

Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
