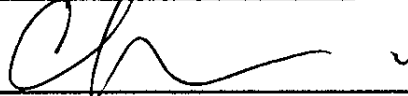

**ARTICLES OF INCORPORATION  
OF  
TRUTH MUSICK MINISTRY CORPORATION**

We, the undersigned natural persons, of the age of twenty-one years or more, acting as incorporators of a corporation pursuant to the NONPROFIT CORPORATION ACT do adopt the following Articles of Incorporation:

**ARTICLE 1. NAME**

The name of this corporation is Truth Musick Ministry Corporation.

**ARTICLE 2. DURATION**

The period of duration for this corporation shall be perpetual or until such time as the Board of Directors shall adopt a resolution recommending that the corporation be dissolved pursuant to the Florida Nonprofit Corporation Act.

**ARTICLE 3. PURPOSES**

This Corporation/Organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation/ organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation/ organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation/ organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/ organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/ organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/ organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by a corporation/ organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

Upon dissolution of this corporation/ organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

#### **ARTICLE 4. MEMBERS**

This corporation shall have no members until and unless such time as the Board of Directors shall adopt a resolution recommending that the corporation accept members, pursuant to the District of Columbia Nonprofit Corporation Act. Upon the decision of the Board of Directors that the corporation admit members, these Articles must be amended.

#### **ARTICLE 5. STOCK**

This corporation shall not have authority to issue capital stock.

#### **ARTICLE 6. REGISTERED OFFICE AND AGENT**

The address of the initial registered office of this corporation is 902 Santa Barbara Rd, Orlando, FL 32808 and the name of its initial registered agent at such address is Cheryl Sutherland, residing in Florida.

#### **ARTICLE 7. AMENDMENTS TO ARTICLES OF INCORPORATION**

This corporation reserves the right to amend or repeal, by the affirmative vote of a majority of the members of its Board of Directors, any of the provisions contained in these Articles of Incorporation.

#### **ARTICLE 8. FUNDS AND ASSETS**

This corporation shall use its funds only to accomplish the purposes stated in these Articles of Incorporation. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law).

#### **ARTICLE 9. DIRECTORS**

The manner in which Directors shall be elected or appointed shall be provided in the Bylaws of the corporation. The names and addresses of the persons who are to serve as initial Directors until their successors are elected and qualified are:
