The undersigned, acting as incorporation of a corporation pursuant to Chapter 617, Florida Status, adopts the following Articles of Incorporation.

ARTICLE I
NAME

PURPOSES

1. To operate as an outreach organization meeting the referral needs of American veterans.
2. To serve as a local, state and national liaison for veterans in need of economic, social or any alternative form of assistance.

3. To plan, organize and sponsor fun activities for the benefit of veterans and their families.
4. The purpose for which the corporation is organized are exclusively charitable and educational within the meaning of section 501© (3) code of the internal revenue code of 1986 or any corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV DISSOLUTION CLAUSE

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation will be distributed to a non-profit 501 © (3) corporation. "However" if the name recipient is not in existence or is no longer qualified as a distribute, or unwilling to accept the distribution, the assets of the organization shall be distribute to a fund, foundation, or organization which is organized and operate exclusively for purpose specified in section 501 © (3) of the Internal Revenue Code.

ARTICLE V LIMITATION OF POWERS

Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under 501 © (3) of the Internal Revenue Code of 1986 or any correspondence provision of any United States Internal Law.



The initial Board of Directors shall be appointed by the initial incorporators.
