LEGAL DESCRIPTION

A portion of Block 29, Guif Beach Manor, a subdivision of a portion of Section 4.
Township 5 South, Range 31 Mest and Section 33, Township 2 South, Range 31 Mest,
Escambia County, Florida as recorded in Plat Book 1, page 16 of the public records
of said County, being more particularly described as follows:

Begin at the southwest corner of Lot 11 of said Block 29; thence North 32

Begin at the southwest corner of Lot II of said Block 29, thence North 32 degrees 05'00" Mest along the east right of way line of Meller Avenue (formerly Escambia Avenue, 80' R/M) for a distance of 1075.46 feet; thence North 66 degrees 39'57" East for a distance of 28.76 feet to the north line of said Gulf Beach Manor; also being the north line of said Section 33 as per plat of Gulf Beach Manor; thence North 66 degrees 00'00" East (this course and the next two courses are along said north line of Section 33 and Gulf Beach Manor) for a distance of 305.26 feet to the southeast corner of Section 31, Township 2 South, Range 31 Mest and the southwest corner of Section 82, Township 2 south, Range 31 Mest as per plat of said Gulf Beach Manor; thence North 67 degrees 42'96" East for a distance of 430.50 feet; thence North 61 degrees 29'00" East for a distance of 144.20 feet to the west right of may line of Kingsport Avenue (formerly Beldon Avenue, 50' R/M); thence South 32 degrees 03'00" East along said mesterly right of way line for a distance of 956.00 feet to the south line of Lot 10 of said Black 29; thence South 57 degrees 57'00" Rest along the south line of said Lots 10 and 11 for a distance of 897.00 feet to the point of beginning.
