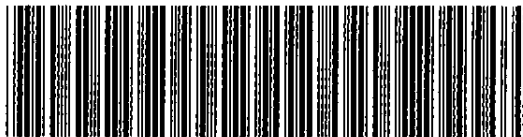

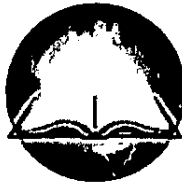

ARTICLES OF INCORPORATION

OF

Freedom In God's Favor Outreach Ministries Organization, Incorporated

The undersigned, a majority of whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Florida, do hereby certify:

ARTICLE I

Name of Corporation and Duration

The name of this corporation is: Freedom In God's Favor Outreach Ministries Organization, Incorporated (hereinafter referred to as the "Corporation") and its duration shall be perpetual.

ARTICLE II

Principal Office

The place in Florida where the principal office of the corporation is to be located is: 1658 West Holden Avenue, #231, Orlando, Florida 32839

ARTICLE III

Statement of Purpose

This corporation is organized exclusively for religious and charitable purposes as we are called to help God's children uniting the community through program services and activities for all ages. Introducing people into a relationship with God by witnessing about God's glory, bring people into worship with Jesus Christ, serving the poor, homeless, hungry, disabled, and otherwise needy. It is our vision to make a difference in our community by reaching out to those that are in need and to those who have not heard the Good News of Jesus Christ.

The purpose of this corporation is:

the income and the principal thereof exclusively for charitable, religious, and educational purposes either directly or by contributions to organizations that qualify as exempt organizations under section 501 (C) (3) of the IRC code and its regulations as they now exist or they may hereafter be amended. More specifically, these purposes shall include but are not limited to:

- ⊕ Develop and implement a Homeless Mission Center with specific related Programs
- ⊕ Develop and implement Community Youth Programs
- ⊕ Develop and implement appropriate Programs for the Elderly
- ⊕ Develop and implement Community Programs for the Disabled and those with Life Threatening Diseases
- ⊕ Develop and implement Community Evangelism, Jail & Penitentiary Programs
- ⊕ Provide Missions Movement in our communities
- ⊕ Connect and network interested agencies, programs, and grass root organizations to form collaborative partnerships that will work together to expand and enhance services to underserved people in their communities.

B. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation.

C. Upon dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations, and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively for the nonprofit charitable, religious, or educational purposes to such organization or organizations which are tax exempt under section 501 (C) (3) of the Code, as amended, as the Board of Directors in its sole discretion shall determine. The extent of personal liability, if any, for directors, officers, or members for corporate obligations and the methods of enforcement and collection, are as follows: NONE. Further, the Directors and Officers shall be exempt from liability and/or indemnified from costs and judgments to the full extent permitted by Florida law. In the event the (Florida) law is subsequently amended to authorize the further elimination or limitation of the liability of Directors or Officers of nonprofit

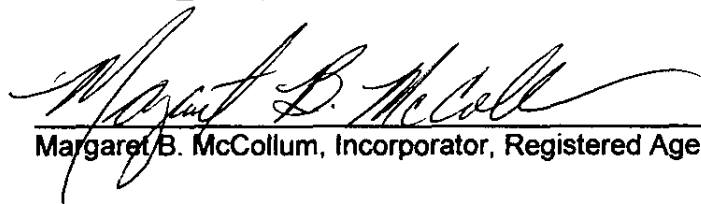
