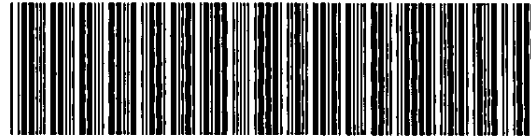

The name of this corporation will be change to: **The Kingdom Center Academy, Inc.**

ARTICLE III (amended)

Purpose(s)

Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt, organizations under Section 501 (c) (3) or the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
