**ARTICLE I  
CORPORATE NAME**

The name of the corporation shall be: **Greater Bethel Primitive Baptist Church of Riviera Beach, Inc., a Florida not-for-profit corporation.**

**ARTICLE II  
PRINCIPAL OFFICE**

The Principal Office shall be located at 1340 W. 30<sup>th</sup> Street, Riviera Beach, FL 33404. The **mailing address** of this corporation shall be Post Office Box 10513, Riviera Beach, FL 33419-0513.

**ARTICLE III  
PURPOSE**

The purpose for which the corporation is organized is for the continuation and furtherance of a religious assembly of a congregation of true and faithful believers in the Christian faith, and for the teaching of religious doctrine of the Primitive Baptist Church organized in 1907, as well as spiritual development and social welfare of its members, the community, and humanity at large.

**ARTICLE IV  
MANNER OF ELECTION**

The manner in which the directors are elected or appointed shall be: By appointment as prescribed in the By-Laws and in accordance with the Discipline of the Primitive Baptist Church.

#### **ARTICLE VIII MANAGEMENT OF CORPORATE AFFAIRS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors ("Board"), consisting of not less than one (1) person. The number of Directors of the corporation shall be five (5), provided however, that such number may be changed by By-Laws duly adopted by the Board.

The Directors named herein as the first Board of Directors shall hold office until the first meeting of the Board at which time any appointments of Directors shall be ratified.

Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting, only if all members of the Board shall individually or collectively consent in writing to such action. Such written consent or consents

shall be filed with the minutes of the proceedings of the Board and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the Directors. Any certificate or other document filed under any provision of law which relates to action so taken shall state that the action was taken by unanimous written consent of the Board of Directors without a meeting, and that the Articles of Incorporation and the By-Laws of this Corporation, if applicable, authorize the Directors to so act. Such a statement shall be prima facie evidence of such authority.

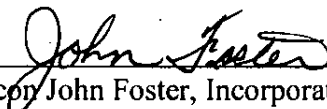
