Article III - Purpose: The purpose for which the corporation is organized is: Exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section or any future federal tax code. To provide through charitable dedication the continuation and futherance of a religious assembly of a congregation of true and faithful believers in the Christian faith, and for the teaching of religious doctrine of the Primitive Baptist Church organized on 1907, as well as spiritual development and social welfare of its members, the community, and humanity at large.

Article X - Provisions: Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, shall dispose of all the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organizations organized and operated exclusively for charitable purposes as shall at the time qualify as an exempt organization under Section 501 (c)(3) of the Internal Revenue Code; as the Board of directors shall determine.

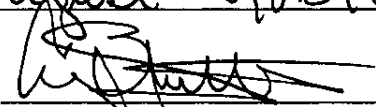
