The undersigned, pursuant to Section 617.1002, Florida Statutes, and the provisions of Article XIII of the Articles of Incorporation of VALENCIA RESERVE HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation (the "Corporation"), do hereby certify as follows:

The name of the Corporation is Valencia Reserve Homeowners Association, Inc.

The Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on December 9, 2008 under Document Number N08000011078 (the "Articles"), under Chapters 617 and 720 of the laws of the State of Florida.

The Board of Directors wishes to amend the Articles in accordance with the requirements of Article XIII of the Articles which provide that, after the First Conveyance and prior to the Turnover Date (as defined in the Articles of Incorporation), the Articles of Incorporation may be amended solely by a majority vote of the Board, without the prior written consent of the Members, at a duly called meeting of the Board.

As of the date of these Articles of Amendment, the First Conveyance has occurred but the Turnover Date has not occurred. Accordingly, the Members of the Association are not entitled to vote on the amendment to the Articles.

The Articles are hereby amended as follows (additions appear as underlined text and deletions appear as strike-through text):

1. Paragraph A of Article X of the Articles is hereby amended to read in its entirety as follows:

The number of Directors on the first Board of Directors of the Association ("First Board") and the ~~"Initial Elected Board"~~ (as hereinafter defined) shall be three (3). The number of Directors elected by the Members as the Initial Elected Board and subsequent to ~~thereto~~ "Declarant's Resignation Event" (as hereinafter defined) shall be an odd number of not less than three (3) nor more than seven (7). The Board shall determine the number of Directors to comprise the Board prior to each meeting at which Directors are to be elected. Except for Declarant-appointed Directors, Directors must be Members or the parents, children or spouses of Members. Each Director shall have only one (1) vote.

2. Paragraph F of Article X if the Articles is hereby amended to read in its entirety as follows:

At the Initial Election Meeting, Purchaser Members, who shall include all Members other than Declarant, ~~the number of which may change from time to time~~, shall elect up to six (6) of the two (2) of Directors determined by the Board as provided in subparagraph A above, and Declarant, until the Declarant's Resignation Event, shall be entitled to designate one (1) Director (same constituting the "Initial Elected Board"). Declarant reserves and shall have the right, until the Declarant's Resignation Event, to name the successor, if any, to any Directors it has to designated.

A majority of the members of the Board of Directors of the Association then in office adopted the foregoing amendments to the Articles of Incorporation at a duly called meeting held on November 12, 2013.

These Articles of Amendment were adopted as of the 12<sup>th</sup> day of November, 2013.
