ARTICLES OF INCORPORATION

OF

STUDENT MINISTRY CENTER, INC.

The undersigned, for the purposes of forming a nonprofit corporation under the Florida Not for Profit Corporation Act, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be STUDENT MINISTRY CENTER, INC. and the principal address and mailing address is 4845 NE 25th Avenue, Ft. Lauderdale, FL 33308.

ARTICLE II

The corporation is a corporation not for profit as defined in Section 617.02, Florida Statutes (1981). The corporation is not formed for pecuniary profit.

ARTICLE III

The corporation is organized exclusively for charitable, religious and educational purposes, including such purposes that qualify as exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE IV

The name and residence of the incorporator to these Articles is as follows: Bruce Herman, 1401 E. Broward Blvd., #206, Ft. Lauderdale, FL 33301.

ARTICLE V

The affairs of the corporation are to be managed by the following officers:

ARTICLE VI

Classes of membership and the voting rights of said membership shall be prescribed in the By-Laws of the corporation. The election of officers and directors shall be as set forth in the By-Laws.


ARTICLE VII

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors or officers, but the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. This corporation shall not have or issue shares of stock.
