



Articles of Incorporation of
INTERNATIONAL RESEARCH FOUNDATION, INC.,
a Florida Not-For-Profit Corporation

The undersigned person, acting as incorporator of a Corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for the Corporation:

ARTICLE I
NAME

The name of the Corporation is: **INTERNATIONAL RESEARCH FOUNDATION, INC.**

ARTICLE II
PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Association shall be: 314 East Dania Beach Boulevard, #103, Dania Beach, Florida, 33004

ARTICLE III
PURPOSES

The Corporation is a not for profit corporation. The general nature and purposes for which this Corporation is formed is to conduct medical and scientific research for the betterment of mankind.

ARTICLE IV
INITIAL DIRECTORS AND/OR OFFICERS

The Board of Directors shall elect the following officers: President, Vice President, Treasurer, and Secretary, and any other officers which the By-Laws of this Corporation authorize the directors to elect. Initially, officers shall be elected at the first annual meeting of the Board of Directors.

Except for the First Board of Directors, directors shall be elected by the members of the Association at the annual meeting of the membership as provided by the By-Laws of the Association, and the By-Laws may provide for the method of voting in the election of directors and for the removal from office of directors.

Duration of Office. Except for the first Board of Directors, Members elected to the Board of Directors shall hold office for the terms set forth in the By-Laws.

If a director elected by the general membership shall for any reason cease to be a director, the remaining directors so elected may elect a successor to fill the vacancy for the balance of the unexpired term.

ARTICLE VII
BY-LAWS

Subject to the limitations contained in the By-Laws and any limitations set forth in the Not For Profit Corporation Act of Florida described above concerning corporate action that must be authorized or approved by the members of the Corporation, the By-Laws of this Corporation may be made, altered, rescinded, added to, or new By-Laws may be adopted, either by a resolution of the Board of Directors or by following the procedure set forth in the By-Laws.

ARTICLE VIII
CORPORATE PROPERTY

The property of this Corporation is irrevocably dedicated to medical and scientific research for the betterment of mankind and no part of the net income or assets of this Corporation shall ever inure to the benefit of any director, officer, or member, or to the benefit of any private individual.

ARTICLE IX
DISSOLUTION

On the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

ARTICLE X
CORPORATE FUNDS

All revenue, profit, income and money received from the conduct of this Corporation, or from membership dues, will be used and employed for furthering the end purpose of said Corporation, and not for the benefit of the members of said Corporation individually.

This Corporation is to have the power to do any and all things necessary or expedient for carrying out the said objects and purposes of the Corporation, and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to corporations not for profit under the laws of the State of Florida.


ARTICLE XI
AMENDMENTS

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote. Amendments may be such adopted by a vote of two-thirds (2/3) of members of the Corporation present and voting at the meeting.


