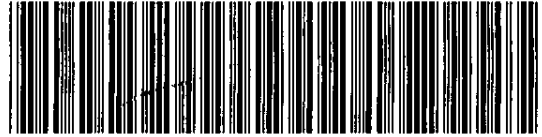

ARTICLES OF INCORPORATION
OF
NEXT GENERATIONS OF HOLOCAUST SURVIVORS, INC.

SECRETARY OF STATE

A Nonprofit Corporation
(Pursuant to Fla. Statutes Chapter 617 Section)

We the undersigned, for the purpose of forming a nonprofit corporation under the Florida Nonprofit Corporation Act, do hereby make and adopt the following Articles of Incorporation:

Article 1
NAME

The name of the Corporation is: NEXT GENERATIONS OF HOLOCAUST SURVIVORS, Inc. and its principal corporate address is located at a street address of 140 SE 5th Avenue #451, Boca Raton, Florida 33432.

Article 2
GENERAL PURPOSE AND RESTRICTIONS

The Corporation is a nonprofit corporation as defined in the laws of Florida . The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under law.

The Corporation shall be operated not for profit, but exclusively for religious, charitable, scientific, literary or educational purposes. Notwithstanding any other provisions of these articles, the Corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Internal Revenue code Section 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Directors or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954(or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954(or the corresponding provision of any future United States Internal Revenue Law).

Article 3
PURPOSES

The Corporation is exclusively organized, and shall be operated exclusively for, the following charitable and educational purposes:

A. To provide funding for educational books, audio-visual, seminars and other resources for the teaching of the holocaust, memorialize the memories of holocaust survivors, provide social assistance to survivors and their families.

B. To exercise all rights and powers conferred by the laws of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by donation, contribution, bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4
INITIAL REGISTERED OFFICE AND AGENT

The street address of the Initial Registered Office of the Corporation 140 SE 5th Avenue Apt. #451, Boca Raton , FL, 33432 and the name of its initial Registered Agent at that address is Nancy Mandel Dershaw.

Article 5
INITIAL BOARD OF DIRECTORS

The management of the Corporation shall be vested in a Board of Directors. The number of Directors constituting the initial Board of Directors is three (3). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three (3). The number of directors and the manner of their election shall be as set forth in the Bylaws. The name and address of each initial Director of the Corporation is as follows:

Article 6
BYLAWS

The Bylaws of the Corporation are to be made and adopted by the Board of Directors, and may be altered, amended or rescinded by the Board of Directors.

Article 7
AMENDMENT

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Directors and Officers are subject to this reservation.

Article 8
INDEMNIFICATION

The Corporation may indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by the Florida Business Corporation Act and the Florida ' s Corporation Not For Profit Act.

Article 9
DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954(or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of pursuant to Florida law and exclusively for such purposes or to such organization or organizations which are organized and operated exclusively for such purposes.

Article 10
COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with the Florida Not for Profit Corporation Act, the date when corporate existence shall commence is the date of subscription and acknowledgement of these Articles of Incorporation.

Article 11
