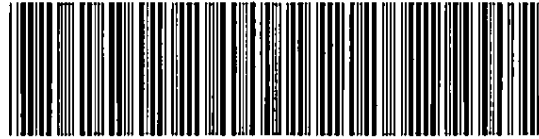

1. The current name of the Corporation is FAIRVIEW COVE CONDOMINIUM ASSOCIATION, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation with the Florida Department of State was December 15, 2008.
3. Article X of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety, as follows:
