**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SECOND NORN TRUSTEE, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation.

FIRST: The date of filing of the Articles of Incorporation was December 15, 2008.

SECOND: Amendment adopted: Article VI of the Articles of Incorporation of SECOND NORN TRUSTEE, INC. should be amended as follows:

ARTICLE VI

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than three persons, the exact number to be determined from time to time in accordance with the By-Laws.
