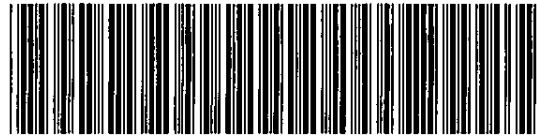

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The primary purpose of the Hernando High Girl's Soccer Booster Club, Inc. is to provide financial and volunteer support to the Hernando High School girl's soccer team(s). Financial support may include, but is not limited to, the purchase of new equipment, soccer bags, warm-up outfits, award and special recognition activities, etc.

The Hernando High Girl's Soccer Booster Club, Inc. shall cooperate with the Hernando County Public Schools Board of Education, Hernando High School's Administration and Athletic Department, and the Hernando High School girl's soccer program coaching staff and ensure the Hernando High Girl's Soccer Booster Club, Inc. maintain the highest possible degree of accountability and efficiency in all operations.

In accordance with Section 501 (c) (3) of the Federal Internal Revenue Code, the Hernando High Girl's Soccer Booster Club, Inc. shall operate exclusively as a non-profit organization. No part of the net earnings shall benefit any private shareholder or individual.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

Any active member of the Hernando High Girl's Soccer Booster Club, Inc. shall be considered eligible for election to any of the Board of Director offices. The voting members of the Board of Directors shall be nominated and elected by the Members at the Annual Meeting for a term of one (1) year or until their successors are elected and will be eligible for reelection annually. Incoming officers shall assume office immediately upon election and shall enter into the performance of their duties and shall continue in office until their successor has assumed office. No more than one member of an immediate family may serve as a voting member of the Board of Directors at the same time.
