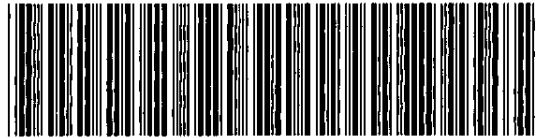

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**Article I.
Name**

The Name of this corporation shall be: G. W. Carver Class of 59, Inc.

**Article II.
Principle Office**

The principle place of business shall be in Miami-Dade County, Florida, with the right to change and move principle place of business within the State of Florida as the Board of Directors may from time to time deem proper. **Article III.
Purpose**

The corporation is organized for the purpose of transacting any or all business for which corporation may be incorporated under the Florida General Corporation Act.
