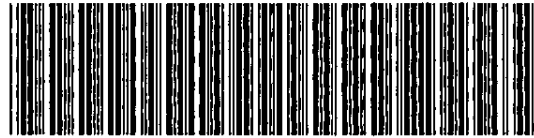

APPENDIX A

Amendment to Articles of Incorporation

By written consent executed as of this date by all of the Directors of Una Fides, Inc. (the "Corporation"), said Directors have agreed that the Articles of Incorporation be amended, and do hereby amend the same, to delete Article III and replace the same with the following new Article III, to wit:

"Article III. Purpose.

The Corporation is organized as a lay educational apostolate in communion and in harmony with the magisterium of the church at all levels and shall be operated exclusively for charitable purposes within the meaning of §501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue Laws) (hereinafter the "Code") to receive and distribute charitable donations to engage in and support the instruction of authentic Catholic religious doctrine among the laity and related religious educational activities in locations determined by the Board of Directors of the Corporation, all as permitted by applicable law, to engage in activities relating to the aforementioned purposes; and to invest in, receive, hold, use, and dispose of all property, real or personal, as may be necessary or desirable to carry into effect the aforementioned purposes. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activity not permitted to be carried on by a corporation: (a) exempt from federal income tax under §501(c)(3) of the Code; or, (b) the contributions to which are deductible under §170(c)(2) of the Code."

The number of votes cast for the Amendment were sufficient for approval.
