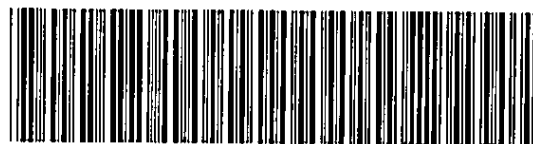

The Distribution of Assets plan which upon motion duly made and unanimously carried is hereby attached to and made part of this Resolution to dissolve SDBC MMTRUST.

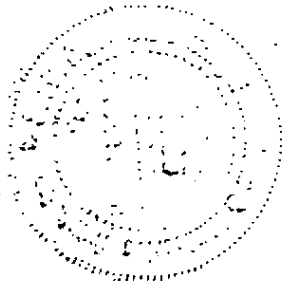
