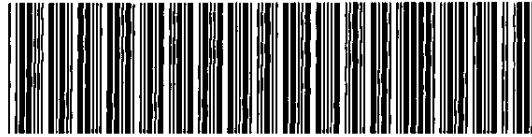

ARTICLE I — NAME

The name of the corporation shall be: **Barack Obama Dollars, Inc.**

ARTICLE II — PRINCIPAL OFFICE

The name corporation's initial principal office shall be located at: 1181 NW 8 Street Road, Apt 15, Miami FL 33136.

ARTICLE III — PURPOSE

The corporation's purpose and mission shall be to exist as a public charity and engage in educational activities such as **helping** students earn accredited college credits in days instead of months without paying tuition, buying books, studying, attending classes, doing homework, commuting, or engaging in activities normally required to earn credits; and **helping** students and parents of students reduce the amount they must borrow to pay for a college education. The corporation will seek tax exempt status in order to apply for grants and solicit contributions from the public which will be used to pay testing fees for low-income students so they can earn college credits in days instead of months, and otherwise help college students further their educational goals in ways consistent with the corporation's purpose and mission.

ARTICLE IV — MANNER OF APPOINTMENT

Officers and directors of the corporation shall be appointed by, and serve at the pleasure of, the corporation's President.

ARTICLE V — INITIAL OFFICER

The corporation's president shall be: Al Feuer, 1181 NW 8 Street Road, Apt 15, Miami FL 33136.

ARTICLE VI — INITIAL REGISTERED AGENT

ARTICLE VII — INCORPORATOR
