ARTICLES OF INCORPORATION OF

RENEWABLE ENERGY PARTNERSHIPS IN EDUCATION INC.

I, the undersigned, acting as incorporator, submit the following Articles of Incorporation for the purpose of forming a nonprofit corporation in compliance with Chapter 617 of the Florida Statutes (Not for Profit), and hereby certify that:

Article I - Name EFFECTIVE DATE 1/1/09

The name of this corporation is **Renewable Energy Partnerships In Education**, **Inc.** hereinafter referred to as "the Corporation."

Article II - Purpose of Corporation

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article III - Tax Exempt Provision
