The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

#### Article I

The name of the Corporation is HAITI CENTER FOR PEOPLE WITH DISABILITIES, CORP; (hereinafter "Corporation").

#### Article II

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under sections 501 (C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### Article III

The Corporation shall have perpetual existence.

#### Article IV

#### Article X

The categories of memberships, qualifications for membership and the manner of admission shall be as set forth in and regulated by the Bylaws of the Corporation.

#### Article XI

Members of the Corporation shall have such voting rights as provided in the Bylaws of the Corporation.

#### Article XII

Neither the members nor the members of the Board of Directors or Officers of the Corporation shall be liable for the debts of the Corporation.

#### Article XIII

The Corporation shall have no capital stock and shall be composed of members rather than shareholders.

#### Article XIV

No part of the net earnings of the corporation shall inure to the benefits of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make no payments and distributions in furtherance of the purposes set forth in article II hereof. No Substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the internal revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under 170 (c) (2) of the internal revenue code, or the corresponding section of any future federal tax code.

#### Article XV

The corporation shall indemnify a director or officer of the corporation who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the director or officer was a party because the director or officer is or was a director or officer of the corporation against reasonable attorney fees and expense incurred by the director or officer in connection with the proceeding. The corporation may indemnify an individual made a party to a proceeding because the individual is or was a director or officer, employee or agent of the corporation against liability if authorized in the specific case after determination, in the manner required by the board of directors, that indemnification of the director, officer, employee or agent of the corporation, as the case may be, is permissible in the circumstances because the director, officers, employee and agent has met the standard of conduct set forth by the board of directors. The indemnification and advancement of attorney fees and expenses for directors, officers, employees and agents of the corporation shall apply when such persons are serving at the corporation's request while a director, officer, employee or agent of the corporation, as the case may be, as a director, officer , partner, trustee, employee or agent of another foreign or domestic corporation, partnership, joint venture, trust ,employee benefit plan or other enterprise, whether or not for profit, as well as in their official capacity with the corporation. The corporation also may pay for or reimburse reasonable attorney fees and expenses incurred by a director, officer, employee or agent of the corporation who is party to a proceeding in advance of final disposition of the proceeding. The corporation also may purchase and maintain insurance on behalf of an individual against same liability under law. All references in these articles of incorporation to director, officer, employee and agent shall include the heirs, estates executors, administrators and personal representatives of such persons.

#### **Article XVI**

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue code, or the corresponding

section of any future tax code, or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **Article XVII**

These articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the Members, and approved at a Members meeting by a majority of the Members, unless all the Directors and all the Members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
