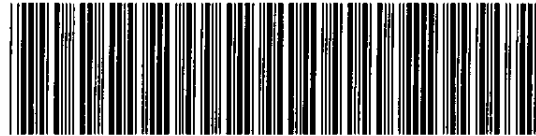





The undersigned for the purpose of forming a for profit Corporation under the laws of the State of Florida , do hereby adopt the following Articles of Incorporation.

**Article I**

**Name**

The name of the corporation shall be **Reaching The Lost Souls Outreach Ministries , Inc .** ( There in after called the "Corporation")

**Article II**

**Principal office And mailing Address**



No substantial part of the activities of the Corporation shall be carrying on the propaganda or otherwise attempting to influence legislations ( except as otherwise provided in subsection (h) of Section 501 ( C) 3 of the internal Revenue Code 1986, as amended) , and the Corporation shall not participate to intervene in ( including the publishing or distribution of statement ) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these article , the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501( C) 3 of the Internal Revenue Code 1986, as amended ( or the corresponding provision of any future United States Internal Revenue Law) or (b) by the corporation , contributions to which are deductible under Section 170 (c) 2 of the Internal Revenue Code of 1986 , as amended ( or the corresponding provision of any future United States Internals Revenue Law).
