CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

PINE RIDGE AT MARTIN DOWNS
VILLAGE I CONDOMINIUM ASSOCIATION, INC.

A Not For Profit Corporation, Incorporated Florida, 1978

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Amended and Restated Articles of Incorporation of Pine Ridge at Martin Downs Village I Condominium Association, Inc., were filed with the Florida Secretary of State on November 1, 1996. The same Amended and Restated Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 1202, Page 1862, et. seq. The same Articles of Incorporation are hereby amended as adopted by at least sixty percent (60%) of the members, which vote was sufficient for approval, at the Members Meetings held on December 29, 2011 and reconvened on January 24, 2012.

1. Article XIV is amended to read as follows:

XIV.

Amendments to these Articles shall be proposed and adopted in the following manner:

- 1. Proposal. Amendments to these Articles may be proposed upon a vote of the majority of the entire Board adopting a resolution setting forth the proposed amendment to these Articles, directing that it be submitted to a vote at a meeting of members or amendments may be proposed by the members of the Association upon a vote of a majority of the voting interests entitled to vote at a meeting for which notice of the proposed amendment has been given.
 - 2. Intentionally Left Blank.
- 3. Vote Necessary. In order for such amendment or amendments to become effective, the same must be approved by a majority of the entire Board and by a majority of the members of the Association. Approval may be expressed by written

consent or by a vote, in person or by proxy, at a duly convened meeting of the Association.

(The balance of Article XIV remains unchanged)

- 2. The foregoing amendment to the Amended and Restated Articles of Incorporation of Pine Ridge at Martin Downs Village I Condominium Association, Inc., was adopted by at least sixty percent (60%) of the members, which vote was sufficient for approval, at the Members Meetings held on December 29, 2011 and reconvened on January 24, 2012.
- 3. The adoption of this amendment appears upon the minutes of said meetings and is unrevoked.
- 4. All provisions of the Articles of Incorporation of Pine Ridge at Martin Downs Village I Condominium Association, Inc., are herein confirmed and shall remain in full force and effect, except as specifically amended herein.


