SUBJECT	DISCUSSION, PROPOSED ACTION & PERSON RESPONSIBLE
1. Approval Of Minutes	The meeting was called to order at 1:00 PM. The Minutes of the previous meeting, held on January 20, 2007 were approved on a motion moved by Neville Thomas, seconded by Lena Lewin. There were two amendments - \$270 were collected in dues and five new members were welcomed.
2. Report- Treasurer	Miss Marston presented the Treasurer's report for 12/30/2006 – 1/31/2007. It showed an opening balance of \$1389.23 and a closing balance of \$ 553.23 resulting from recurrent expenses and preparatory costs for the 3/9/2007 fund-raiser.
3. Other Reports	• The President extended condolences to the Lewin family on their recent loss. • The IRS has granted the Alliance an EIN number. (EIN -06-1804344) • At present the Alliance is definitely not tax-exempt. We will seek advice on the procedure and obligations this status will entail from a CPA or attorney.
4. Chamber	The President reported that she had contacted the Chamber of Commerce. Fees are: \$240.00 per year with a one-time registration fee of \$20.00. CAAFI will join the Chamber of Commerce.
5. Fund – Raising	As the scholarship fund is a priority, plans for the fund-raiser on March 9, 2007 – Caribbean Night in Ocala, at the Ocala Golf Course, were the main focus of discussion. Ticket sales have been slow. Members were encouraged to step up their efforts. Advertising will be increased (via the Star Banner and the website.)
6. Website	Members were again encouraged to visit the website and critique it.
7. Next Meeting	The next meeting will be held on 3/17/2007 at 1:00 PM at Silver Springs Presbyterian Church. The Board will meet at 12 noon, as usual – just before the general meeting
