1. The name of the Corporation is UNITY SCHOOL ENDOWMENT FUND, INC., filed under File No. N08729 on April 16, 1985.



PLAN OF LIQUIDATION

1. This Corporation shall be dissolved and liquidated effective June 30, 2023 ("Effective Date").

2. Upon the adoption of this Plan of Liquidation by the members of the board of directors the proper officers of the Corporation shall execute and file Articles of Dissolution with the Florida Department of State.
