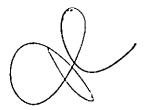

CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF BERN CREEK IMPROVEMENT ASSOCIATION, INC.

AND

AMENDED AND RESTATED BYLAWS OF BERN CREEK IMPROVEMENT ASSOCIATION, INC.

THIS CERTIFICATE OF AMENDMENT is executed on the date indicated below by Em Creek Improvement Association, Inc., a Florida not-for-profit corporation (hereinafter the "Association").

RECITALS

WHEREAS, the Association has been established for the operation of Bern Creek Improvement Association, Inc., in accordance with the Restated Declaration of Restrictions of The Ranches at Bern Creek, that was recorded on August 9th, 2011 at Instrument #2011092854 of the Public Records of Sarasota County, Florida, as amended from time to time ("the Declaration"); the Articles of Incorporation of Bern Creek Improvement Association, Inc. that were recorded with the State of Florida on April 19, 1985, and in the Public Records of Sarasota County on March 28, 2017, at Official Records Instrument #2017037104, as amended from time to time ("the Articles of Incorporation"); and the Amended and Restated Bylaws of Bern Creek Improvement Association, Inc., that were recorded on May 23, 2014 as Instrument #2014060574 of the Public Records of Sarasota County, Florida, as amended from time to time ("the Bylaws"); and,

WHEREAS, the amendment to the Articles of Incorporation was submitted to the Members of the Association at the meeting of the Members held on December 4, 2023, which Meeting was duly noticed in accordance with the Florida Statutes; and,

WHEREAS, the amendment to the Articles of Incorporation was approved by a majority of the membership at a membership meeting; and,

WHEREAS, pursuant to its Article VIII, the power to amend the Bylaws of Bern Creek Improvement Association, Inc. is reserved unto the Board of Directors, which can approve any such amendment with an affirmative vote of a simple majority of the Board. No vote of the owners is required,

WHEREAS, the amendments to the Bylaws were approved by a majority of the Board of Directors of the Association at a meeting on December 4, 2023;

NOW THEREFORE, the Association does hereby state as follows:

- 1. The foregoing recitals are true and correct and are incorporated herein by reference.
- 2. All present and future Members of the Association shall be bound by the amendments to the Articles of Incorporation and Bylaws.

New language is indicated by underlined type. Deleted language is indicated by strikethrough type.

I. Amendments to the Articles of Incorporation:

Article VI of the Articles of Incorporation is amended as follows:

ARTICLE VI. OFFICERS

The affairs of the corporation shall be managed by the following officers, subject to the control of the Board of Directors: a President, and a Secretary, and a Treasurer, and by such additional officers either elected or appointed as may from time to time be provided by the Bylaws.

The President, and Secretary, and Treasurer shall be elected annually in the manner provided in the Bylawsby the membership at its regular annual meeting. Vacancies may be filled by the Board of Directors at any time, at either a regular or special meeting. Every officer shall be a member of the corporation. A person may hold one or more offices except that the President shall not also be the Secretary.

II. Amendments to the Bylaws:

Section 2 of Article I is amended as follows:

Section 2. Resident and Resident Agent's Office:

The resident agent for services of process of this corporation is the Corresponding Secretary. The address of the resident agent of the corporation is Bern Creek Improvement Association, c/o Tannenbaum Lemole & Hill, 614 S. Tamiami Tr., Osprey, FL 34229 All Florida Services, Inc., 2831 Ringling Blvd., Ste 218F, Sarusota, Florida, 34237. The Board may change the Association's registered agent and office in the manner provided by law.

Section 2 of Article III is amended as follows:

Section 2. Meetings:

An annual meeting shall be held on a date chosen by the Board in the month during the first week of December to conduct corporation business. In addition, the election of directors for the corporation shall take place as described below. Additional meetings of the members shall be at the call of the Board of Directors. A quorum to hold the meeting shall consist of representatives from twenty-five (25) lots. At the annual meeting the Board of Directors shall present a budget to the members for the upcoming year. A simple majority of the members present is required to approve the budget.

Section 6 of Article VI is amended as follows:

Section 6. Secretary – Powers and Duties:

The Secretary shall attend all meetings of the Board of Directors and of the members and shall keep or cause to be kept a true and complete record of the proceedings of those meetings. He shall give, or cause to be given, notice of all meetings of the directors or of the members and shall perform whatever additional duties the Board of Directors and the President may from time to time prescribe. With the approval of the Board, any of these duties may be delegated to the Association's manager.

Section 2 of Article VII is amended as follows:

Section 2. Signing of Checks and Notes:

Checks, notes, drafts and demands for money shall be <u>authorized</u> signed by two officers from time to time as designated by the Board of Directors. The Board of Directors may <u>authorize electronic payments in its discretion.</u>

A new Article IX is added as follows:

Article IX. CONFLICT

The governing documents shall control in the following order of priority: the Declaration; the Articles of Incorporation; these Bylaws; and the Rules and Regulations. In the event of any conflict between the provisions hereof and the Homeowners' Association Act, that Act shall control.

All other Sections remain unchanged.
