ARTICLES OF INCORPORATION

OF

LEADERSHIP PALM BEACH COUNTY, INC.

The undersigned hereby executed these Articles of Incorporation for the purpose of becoming incorporated under Chapter 617, Revised Florida Statutes, as a corporation not-for-profit, and certifies as follows:

ARTICLE I

NAME OF CORPORATION

The name of the Corporation shall be: LEADERSHIP PALM BEACH COUNTY, INC.

ARTICLE II

PURPOSES FOR WHICH ORGANIZED

This Corporation is organized not for profit and the objects and purposes to be exclusively transacted and carried on are:

1. To sponsor a series of educational programs in order to develop the leadership abilities of residents of Palm Beach County, Florida;
2. To promote the involvement of residents of Palm Beach County, Florida in civic organizations and community activities which benefit Palm Beach County; and
3. To do and undertake such other activities as the Board of Directors shall from time to time determine to be necessary to carrying forward the above purposes of the Corporation;

ARTICLE III

PROHIBITED ACTIVITIES

1. No part of the earnings of the Corporation shall inure to the benefit of any member, Director or Officer of the Corporation, or any other person (except that the Corporation may pay reasonable compensation for services rendered to or on behalf of the Corporation and make other payments and distributions in furtherance of one or more of its purposes), and no member, Director or Officer of the Corporation, or any other person shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation;

2. No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. The Corporation shall not participate, directly or indirectly, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Corporation shall not have the objectives nor engage in activities which would characterize it as an "action organization" as defined in Treasury Regulation §501(c)(3)-1(c)(3), as it now exists or may be hereafter amended;

3. Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, and Treasury

Regulations thereunder as they now exist or as they may be hereafter amended, or by any organization, contributions to which are deductible under Sections 170(e)(2) and 1955(b) of such Code and Treasury Regulations thereunder as they now exist or as they may be hereafter amended; and

4. Upon the dissolution of the Corporation or the winding up of its affairs, all of the assets of the Corporation shall be distributed to such organizations which then qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended, as the Board of Directors may direct.

#### ARTICLE IV

##### POWERS

In order to accomplish the purposes and to attain the objects for which this Corporation is formed and for which the funds and property of this Corporation shall be handled, administered, operated and distributed as hereinabove set forth, the Corporation, its Directors and Officers, shall possess and exercise all powers, authorities and privileges granted by and allowed under the laws of the State of Florida, subject to the limitation and condition that, notwithstanding any other provision of these Articles, only such powers shall be exercised as are in furtherance of the Federal income tax exempt purposes of the Corporation and as may be exercised by an organization exempt under Section 501(c)(3) of the Internal Revenue Code, as amended, and Treasury Regulations thereunder

as they now exist or as they may be hereafter amended and of the organization, contributions to which are deductible under Sections 170(c)(2) and 2055(a) of such Code and Treasury Regulations thereunder as they now exist or as they may be hereafter amended.

#### ARTICLE V

##### NONSTOCK CORPORATION

This Corporation shall not have or issue shares of stock, however, it may have and issue membership certificates.

#### ARTICLE VI

##### REGISTERED OFFICE AND REGISTERED AGENT; PRINCIPAL PLACE OF BUSINESS

The Corporation's Registered Office in this State is located at 310 Okeechobee Boulevard, West Palm Beach, Florida 33401 and the name of the Registered Agent of the Corporation at that address is Barry S. Berg. The Board of Directors may from time to time move the Registered Office to any other street address in Florida and may establish branch and other offices within or without the State of Florida.

#### ARTICLE VII

##### TERM OF CORPORATE EXISTENCE

The term for which this Corporation shall exist is perpetual.

ARTICLE VIII

MEMBERSHIP

Membership in this corporation shall be available in accordance with the qualifications for members and manner of admission as shall be set forth in the By-Laws, which may include without limitation, assessment of dues for members.

ARTICLE IX

BOARD OF DIRECTORS

The corporate powers of the Corporation shall be vested in a Board of Directors, which shall consist of at least seven (7) but not more than thirty (30) members, as shall be provided in the By-laws. Where not inconsistent with Chapter 617, Florida Statutes, and the express provisions of these Articles, the Board of Directors shall have all the rights, powers and privileges prescribed by law for directors of profit corporations.

The qualifications and terms of office, manner of nomination and election of members of the Board of Directors, and the time, place and manner of calling meetings, giving notice of and conducting the meetings of the Board of Directors, and the number of Directors which shall constitute a quorum at the meetings of the Board of Directors shall be as prescribed in the By-laws of the Corporation.

#### ARTICLE XI

##### INDEMNIFICATION OF DIRECTORS AND OFFICERS

1. The Corporation hereby indemnifies any Officer or Director made a party or threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding:

(a) Whether civil, criminal, administrative, or investigative, other than an action, suit, or proceeding by or in the right of the Corporation to procure a judgment in its favor, brought to impose a liability or penalty on such person for an act alleged to have been committed by such person in his capacity as director, officer, employee and/or agent of this or any other corporation, partnership joint venture, trust or other enterprises which he served at the request of the Corporation, against judgments, fines, amounts paid in settlement and reasonable expenses, including attorneys' fees, actually and reasonably incurred as a result of such action,

suit or proceeding or any appeal therein, if such person acted in good faith in the reasonable belief that such action was in or not opposed to the best interests of the Corporation, and in criminal actions or proceedings, without reasonable ground for belief that such action was unlawful. The termination of any such action, suit or proceeding by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent shall not in itself create a presumption that any such director or officer did not act in good faith in the reasonable belief that such action was in or not opposed to the best interests of the Corporation or that he had reasonable ground for belief that such action was unlawful.

(b) By or in the right of the Corporation to procure a judgment in its favor by reason of such person's being or having been a Director or officer of the Corporation, or by reason of such person's serving or having served at the request of the Corporation as a director, officer, employee and/or agent of any other corporation, partnership, joint venture, trust or other enterprise, against any expenses, including attorneys' fees, actually and reasonably incurred by him in connection with the defense or settlement of such action, or in connection with an appeal therein, if such person acted in good faith in the reasonable belief that such action was in or not opposed to the best interests of the Corporation. Such person shall not be entitled to indemnification in relation to matters as to which such person has been adjudged to have been guilty of gross negligence or willful misconduct in the performance of his duty to the Corporation.

2. Any indemnification under Paragraph 1(a) above shall be made by the Corporation only as authorized in the specifications set upon determination that amounts for which a Director or officer seeks indemnification were properly incurred and that such Director or officer acted in good faith and in a manner he reasonably believed to be in or not opposed to the best interest of the Corporation, and that, with respect to any criminal action or proceeding, he had no reasonable ground for belief that such action was unlawful. Such determination shall be made by the Board of Directors by a majority vote of a quorum consisting of Directors who were not parties to such action, suit, or proceeding.

3. The Corporation shall be entitled to assume the defense of any person seeking indemnification pursuant to the provisions of Paragraph 1(a) above upon a preliminary determination by the Board of Directors that such person has met the applicable standard of conduct set forth in Paragraph 1(a) above, and upon receipt of an undertaking by such person to repay all amounts expended by the Corporation in such defense, unless it shall ultimately be determined that such person is entitled to be indemnified by the Corporation as authorized in this Article. If the Corporation elects to assume the defense, such defense shall be conducted by counsel chosen by it and not objected to in writing for valid reasons by such person. In the event the Corporation elects to assume the defense of any such person and retain such counsel, such person shall bear the fees and expenses of any additional

counsel retained by him, unless there are good reasons for such  
as between the Corporation and such person, and the interests  
interests between or among such person and other parties  
represented in the same action, suit or proceeding by such  
counsel retained by the Corporation, that are for valid  
reasons, objected to in writing by such person, in which case  
the reasonable expenses of such additional representation shall  
be within the scope of the indemnification intended if such  
person is ultimately determined to be entitled thereto as  
authorized in this Article.

4. Indemnification as provided in this Article shall  
continue as to a person who has ceased to be a Director,  
officer, employee, or agent and shall inure to the benefit of  
the heirs, executors, and administrators of such a person.

5. The foregoing rights of indemnification shall not be  
deemed to limit in any way the powers of the Corporation to  
indemnify under applicable law.

#### ARTICLE XII

##### AMENDMENTS

These Articles of Incorporation may be amended by a vote of  
a majority of those present at any regular or special meeting  
of the Board of Directors, provided a quorum is present, and  
provided also, in the case of a special meeting, that said  
meeting shall have been called for the purpose of such  
amendment.
