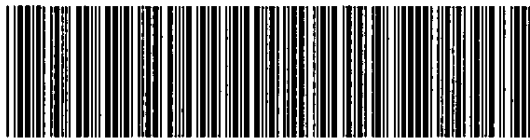

Amended Article III. Purpose

TheSunCoast Chamber of Commerce Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions, that qualify as an exempt organization under section 501(c)3 of the internal code or any corresponding section of any future federal tax code.

Amended Article IX. Distribution of Assets

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the internal Revenue code, or corresponding section of any future code, or shall be distributed to the federal government or to a state or local government, for the public purpose. Any such assets not be disposed of by the court of common pleas of the county in which the principal office of the organization, is located, exclusively for such purposes or to such organization, as said court shall determine, which is organized and operated exclusively for such purposes.
