Article III - Purpose -

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Said corporation performs animal-assisted activities, such as; visit seniors in nursing homes, assisted living facilities, and day care centers for medically fragile children, visit special needs children in hospitals, schools, respite programs, plus helping children gain confidence with their reading by reading to a trusted therapy dog, at libraries and schools. #### ARTICLE VI: Dissolution
