## Articles of Incorporation of Bullets Baseball Gold Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to promote the development and growth of young boys through competitive travel baseball. We aim to foster an environment in which children can develop valuable life skills while learning the game of baseball.
