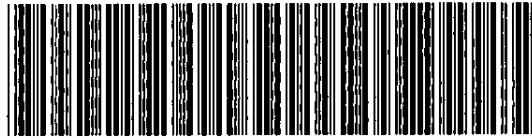

There are no limitations on the corporate powers authorized under Chapter 617, Florida Statutes.

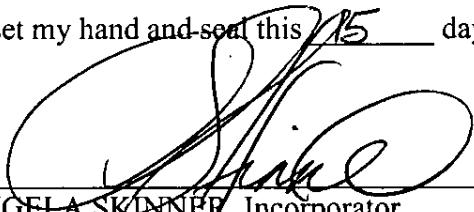
