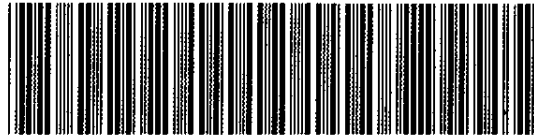

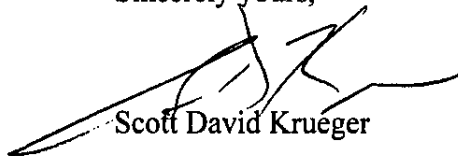

ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following of Incorporation, effective January 2, 2009:

Article I  
NAME

The name of the Corporation is A Rai of Sunshine Of North Florida, Inc. The initial principal place of business and mailing address of this corporation shall be:

1801 Northeast 23<sup>rd</sup> Avenue

Gainesville, Florida 32609

Article II  
NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Member, Directors or Officers, except to the extent permissible under law.

**Article III**  
**DURATION**

The duration of the Corporation is perpetual.

**Article IV**  
**PURPOSES**

The Corporation is organized, and shall be operated exclusively for assisting those in need and other charitable purposes, and is intended to be classified as an organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donated or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**Article V**  
**LIMITATION**

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4 (Purposes) hereof.

**Article VI**  
**MEMBERS**

The Bylaws may provide for Voting and Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, and who may or may not have the right to vote.

**Article VII**  
**INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial Registered Office of the Corporation is 2750 Northwest 43<sup>rd</sup> Street, Suite 201, Gainesville, Florida 32606, and the name of its initial Registered Agent at that address is Scott David Krueger.

**Article VIII**  
**INITIAL BOARD OF DIRECTORS**

The management of the corporation shall be vested in a Board of Directors. The number of Directors constituting the initial

Board of Directors is seven (7). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three. The Directors shall be elected as provided for in the Bylaws. The name and address of each initial Director of the Corporation is as follows:

**Article XI**  
**BYLAWS**

The Bylaws of the Corporation are to be made and adopted by the Board of Directors, and may be altered, amended or rescinded by the Board of Directors.

**Article XII**  
**AMENDMENT**

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Trustees and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provisions for amendments are adopted by the Corporation pursuant to law.

**ARTICLE XIII**  
**Taxation Limitation**

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be

carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

**ARTICLE XIV**  
**Dedication of Assets**

The Corporation dedicates all assets which it may acquire to the purposes set forth under these Articles hereof. In the event that the Corporation shall dissolve or otherwise terminate its corporate existence, the Corporation shall distribute all its existing assets to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any future law, or to the federal government or to a state or local government for the exclusive public purpose.
