

ARTICLES OF AMENDMENT

of the

ARTICLES OF INCORPORATION

of

SHURA OF ISLAMIC FAMILY COUNSELORS OF AMERICA, INC.

Shura of Islamic Family Counselors of America, Inc., organized on January 7, 2009 in Broward County, Coral Springs, Florida, pursuant to the provisions of the Florida Not For Profit Corporation Act, desiring to give notice of corporate action amends its Articles of Incorporation to include an additional Article in the following manner:

ARTICLE VIII

The purposes for the formation of the Corporation are the following:

- (A). Exclusively charitable and education within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any further United States Internal Revenue Law. The organization has among its purposes, including but not limited to, the establishment of a place of worship and the provision of recreational, cultural, religious, and educational programs for worshippers, and any and all other matters associated with an educational and charitable corporation.
- (B). In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations, which themselves are exempt as organizations described in Section 501(c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding sections of any future federal tax code, to be used exclusively to accomplish the general purposes for which this Corporation is organized.
- (C). The Corporation will engage in any other lawful activities whatsoever that are necessary, incident, or convenient to the carrying on of such activities or are intended to promote, directly or indirectly, such interest of the Corporation, and to exercise any and all powers that it might now or hereafter be lawful for the Corporation Code or any act amendatory thereof or supplemental thereto that may now or hereafter be in force and effect.

The above amendment was adopted by the Board of Directors of Shura of Islamic Family Counselors of America, Inc., at a duly called meeting of the board held on June 18, 2010 at 11130 N.W. 34th Place, Coral Springs, Broward County, Florida 33065. The amendment was adopted by vote of the members of the corporation, as required.
