#### Article I Name

The name of the corporation shall be Paws in Prison, Inc.

#### Article II Principal Office

The principal STREET address and mailing address is:

84 Council Moore Rd. Crawfordville, FL 32327

#### Article III Purpose

The purpose for which the corporation is organized is exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code.

- (a) Our mission is to promote the respectful humane treatment of animals and inmates, to promote rehabilitation for both dog and inmate, and to provide education to the community.
- (b) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its trustees, officers, or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements)any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (c) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### Article IV Manner of Election

The original board of directors shall be appointed for a term of two years. After two years, each member will nominate 2 nominees for each vacancy. The board will vote in three new board me The President will remain on the board as an at large member for the term following his/her pre If a vacancy occurs on the board during the year after an annual meeting, then a new Director appointed by the Board of Directors.
