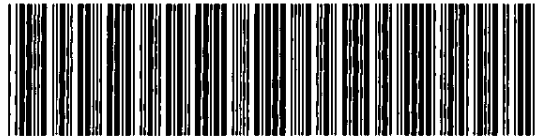

The name of the corporation is Support The Heroes, Inc.

**Article 2.**

### Article 9.
