## **FLORIDA NON FOR PROFIT ARTICLES OF INCORPORATION**

### Article I. Name

The name of this Florida Corporation is:

### Article III. Purpose of the Corporation

The purpose of this non-profit organization is to benefit and enhance the quality of life for youthful surfers and prospective surfers across the world by supporting environmental, educational, health and youth-related projects. In particular to further Thomas M. "Mike" Arnold's life purpose of teaching surfing and water safety to young people.

The said corporation is organized for charitable and educational purposes including for such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

### Article IV. Fundraising Activities:

The main fundraising activities will be through donations and the development and sponsorship of surf contests for young surfers.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
