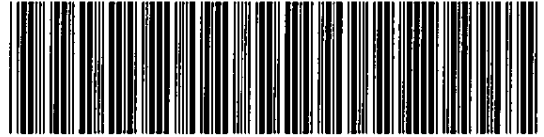

**ARTICLES OF INCORPORATION OF
YOUTH & FAMILY ASSOCIATION INC.
(FLORIDA NON-PROFIT ASSOCIATION)**

THE UNDERSIGNED, each with the capacity to contract, hereby executes and acknowledge these Articles of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Florida.

THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLES I. NAME.

The name of this corporation shall be Youth & Family Association, Inc..

ARTICLES II. PRINCIPAL OFFICE.

The principal street address and mailing address of this corporation is 700 N. Forsyth Rd, Orlando, FL 32807.

ARTICLES III. PURPOSE.

The purpose for which the corporation is organized is:

- To provide a caring, loving and healthy environment so that youth and their families can come together to learn, exercise and develop positive values.
- To help youth and family build stronger bonds.
- To guide youth and family get involved and volunteer in communities in a caring and positive way.

ARTICLES IV. MANNER OF ELECTION.

The method of election of the corporation's directors shall be stated in the bylaws.

ARTICLES V. TERM.

The date of commencement of corporation existence shall be when these Articles have been filed with the department of State and approved by it, and the respective filing fee has been paid. The term for which the corporation is to exist shall be perpetual. This corporation is organized and operated within the meaning of non-profit association. In the event of dissolution of the corporation, no part of the corporation's assets shall inure to the benefit of any of its members; the residual assets of the corporation shall be distributed to one or more non-profit organizations or to the federal, state or local government for exclusive public purpose.

ARTICLES VI. NON-PROFIT ASSOCIATION.

No part of the net earnings of the corporation shall ever inure to the benefit of or to be distributed to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Articles III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLES VII. FOUNDER.

The founder of the corporation is Tom Vu.

ARTICLES VIII. INITIAL REGISTERED OFFICE AND AGENT.

The name of the initial agent of the corporation is William D. Slicker, Attorney at law, and the street address of the Initial Registered Office of this corporation is 4554 Central Avenue, suite E, St Petersburg, FL 33711.

ARTICLES IX. INCORPORATOR.

ARTICLES XI. BOARD OF DIRECTORS.

The Board of Directors of the corporation shall consist of no less than three (3) directors as determined by the Bylaws. The founder selects the Board of Directors at the time the corporation is filed. After the first year, Directors shall be selected at the annual meeting (which is on the last Sunday of December of each year) of the Board of Directors in the manner set forth in the Bylaws. Directors may be removed and vacancies shall be filled in the manner provided by the Bylaws.

The Directors named in these Articles shall serve as director for the ensuing year, any vacancies before then shall be filled in the manner set forth in the Bylaws. The Founder shall have the authority to make provision for reasonable compensation to the Directors for their services and to fix the basis and condition upon which this compensation shall be paid.


