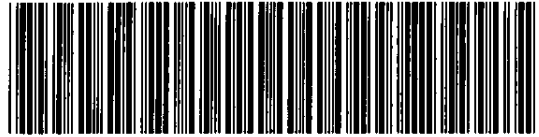

**ARTICLES OF INCORPORATION
FOR
N.T. WALKER HUMAN RESOURCE CENTER FOUNDATION, INC.**

ARTICLE 1.

The name of this corporation is The N.T. Walker Human Resource Center Foundation, Inc. This nonprofit corporation is organized for general purpose, pursuant to the Federal Corporation Not For Profit Laws as set forth in Chapter 617, Florida Statutes, and shall have perpetual existence. The corporation shall commence existence on the date these Articles are filed with the Secretary of State.

ARTICLE 11.

The location and mailing address of the principal office of the corporation is 143 N. Rodriquez Street, St Augustine, Florida 32095.

ARTICLE 111.

The purposes for which this corporation is organized are:

- (a) To operate in any manner supportive of religious, charitable and educational efforts consistent with the criteria to qualify as an exempt organization under section 501(c) 3 of the Internal Revenue Code of 1986, as amended or for any corresponding purpose of any future Internal Revenue laws, including laws for private foundations;
- (b) To develop, maintain, provide, and participate in educational and health programs for the general public, for churches and religious organizations, and for private groups;
- (c) To provide support and assistance for community development and economic development; and
- (d) To receive, invest, and disburse funds and to hold property for the purpose of the corporation.

ARTICLE IV.

The number of Directors of the Foundation shall not be more than (13) thirteen nor less than (7) seven. The manner in which the Directors are elected or appointed shall be set forth in the By-Laws of the Corporation which are to be adopted at the initial meeting of the Directors.

ARTICLE V.

In the event of the disposition or abandoned property of the Foundation, or upon dissolution, voluntarily or otherwise, the assets of the Foundation shall not inure to the benefit of any member or individual, but shall be transferred to one or more other exempt Foundations as described in Section 501(c)3 or 170(c)2 of the Internal Revenue Code of 1986. Which shall have as its primary purpose those same responsibilities as specified in Article III hereof or as may be performed by the Directors of this Foundation in furtherance of such responsibilities.

ARTICLE VI.

The corporation shall be expressly prohibited from conducting or carrying on propaganda or otherwise attempting to influence the Legislature, or intervening in any political campaign on behalf of any candidate for public office, or any other activity not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)3 of the Internal Revenue Code of 198, or any other corresponding provisions of any future Internal Revenue Laws.

ARTICLE VII.

The subject to such express restrictions and conditions as set forth herein or otherwise applicable under any federal or state law or regulation, the By-Laws of the corporation may be altered, amended, rescinded, adopted or added to by appropriate action of the Directors of the corporation at a meeting of the Directors and in a time and manner provided for in the By-Laws.

ARTICLE VIII.

That subject to such express restrictions and conditions as set forth herein or otherwise applicable under and federal or state law or regulation, any amendment to the Articles of Incorporation shall be proposed, voted on, and adopted by resolution at the time and in the manner provided for in the By-Laws at an annual or special meeting of the Directors, and the resolution adopted shall be transmitted to the Secretary of State as provided in Chapter 617, Florida Statutes.

ARTICLE IX.

Each officer, director, employee and agent of the corporation shall be entitled to indemnification by virtue of their acts on behalf of the corporation and to the full extent provided in Section 607.0850 and Section 671.028, Florida Status, as amended from time to time.


