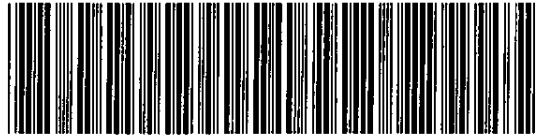

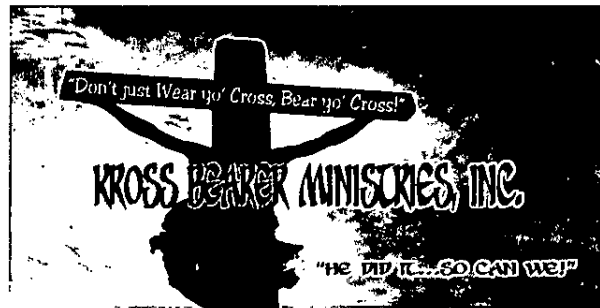

**THE ARTICLES OF INCORPORATION
FOR
KROSS BEARER MINISTRIES, INC.
(FLORIDA NOT-FOR-PROFIT CORPORATION)
IN COMPLIANCE WITH CHAPTER 617, F.S. (NOT-FOR-PROFIT)**

The undersigned, for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

Article I
Name

The name of the corporation shall be
Kross Bearer Ministries, Inc.
(Hereinafter called the "Corporation")

Article II

Article III
Purpose

The specific purpose of this not-for-profit Corporation is for the charitable, religious and educational training purposes in Section 501(c) 3 of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit Corporation may be organized, so for as is or may be permitted by laws of the State of Florida & Section 501(c) 3 of the Internal Revenue Code 1986 as amended by Kross Bearer Ministries, Inc.

Also, there will be several programs organized to operate through
Kross Bearer Ministries, Inc.

Article IV
Membership

Any person, relative, Corporation, Partnership, Association or Organization who is interested in the purpose of the Corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the Corporation, and who complies with the requirements established from time to time by the by-laws, shall be eligible for membership.

Article V
Board of Directors

A Board of Directors consisting of no less than three (3) Directors shall manage the affairs of this Corporation. The number of Directors may be increased or decreased from time to time, in accordance with the by-laws of the Corporation, but shall never be less than three (3). The manner of election of Directors shall be regulated by the by-laws.



Article VIII
Dissolution

Upon the dissolution of winding up of this Corporation, it's assets remaining after payment of provisions for payment of all debts and liabilities of the Corporation shall be distributed to a not-for-profit fund, foundation or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) 3 of the Internal Revenue Code 1986, as amended, or corresponding provisions of any subsequent federal tax laws

Article IX
Limitations

No part of the net earning of the Corporation shall inure to the benefit of, or be distributed to it's Directors, Officers, Members or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of any of it's purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501 (c) 3 of the Internal Revenue Code 1986, as amended), and the Corporation shall not participate or intervene in (including the publishing or distribution of statement) any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c) 3 of the internal Revenue code 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a Corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).




