AND MAN CONTRACTOR OF THE PARTY Article of Incorporation of the undersigned, a majority of whom are citizens of the United States desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law under Chapter 617, Florida Statutes, do hereby certify:

ARTICLE I NAME

The name of this corporation shall be South and Eastern Indian Tribal Preservation, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which this corporation is organized is to document and record the American Indian Tribes in the eastern United States. This would include Tribes located in Florida, North Carolina, Louisiana, Mississippi and New York. The preservation work would include language, art, music, and lifeways (moral stories and traditions). The foundation would work with Tribal citizens in every capacity of recording the culture in its truest, most authentic form. The director and script writers will feature Native Indian talent and use Tribal talent whenever possible and appropriate.

To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV MANNER OF ELECTION

(The manner in which the directors are elected or appointed.)

The incorporators of the corporation shall select the first slate of the Board of Directors of the corporation. Thereafter, the directors shall select successors. A director may succeed himself or herself in office. The term of office for each director of this corporation shall be 4 years, or until his or her successor is elected. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
