Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

Article III

The specific purpose for which this corporation is organized is:

TO RAISE FUNDS FOR UNIVERSITY OF SOUTH FLORIDA COLLEGE OF MEDICINE, USF FOUNDATION, OR ANY OTHER CHARITY REGISTERED AS A 501 C 3 NOT FOR PROFIT CORPORATION AS SELECTED BY THE BOARD OF DIRECTORS. FUNDS ARE TO BE RAISED BY ORGANIZING AND CONDUCTING GOLF TOURNAMENTS OF OTHER SPORTING EVENTS AND TRANSMITTING THE NET FUNDS RAISED TO THE SELECTED CORPORATION.


Article IX

UPON DISSOLUTION OF THIS ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 C 3 OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.

The effective date of these amendments is June 4, 2009.

The amendments were adopted by the members and the number of votes cast for the amendments were sufficient for approval.
