**ARTICLES OF AMENDMENT
TO
UNITED HANDS GROUP, INC
A Florida not-for-profit corporation**

Pursuant to the provisions of Section 617.1006 Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is United Hands Group, Inc. The Articles of Incorporation were filed on January 29, 2009 and assigned document number N09000000916.

2. Article VII of the Articles of Incorporation is deleted in its entirety and the following is adopted and replaced by the Corporation and substituted in lieu thereof as follows:
