**(Florida not-for-profit corporation)**

The undersigned, acting as the incorporator of **THE THOMLIN EDUCATIONAL AND SOCIAL SOCIETY INCORPORATED**, a not-for-profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617, Florida Statutes, as amended, (hereinafter referred to as the "Corporation") and as President of the Corporation, by virtue of the authority granted in Resolution 2008 approved by a majority of the Corporation's Board of Directors at its October 21, 2008, meeting, hereby adopt the following Articles of Incorporation for the Corporation:

**ARTICLE I: NAME**

The name of the Corporation shall be: **THE THOMLIN EDUCATIONAL AND SOCIAL SOCIETY INCORPORATED**, hereinafter referred to as the "Corporation."

**ARTICLE II: OFFICE AND MAILING ADDRESS**

The address of the principal office and the mailing address of the Corporation is: 3771 NW 4<sup>th</sup> Place, Ft. Lauderdale, Florida 33311.

**ARTICLE III: PURPOSES**

The Corporation is organized and operated exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any future corresponding provision of any future United States Internal Revenue Law; or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended, or any future corresponding provision of any future United States Internal Revenue Law.

The primary purpose of this organization is to provide educational and social service assistance and opportunities to residents of Broward County. The agency will focus on the development and promotion of prevention educational activities designed to improve the health and social welfare of our community.

The corporation will work in the community to develop and promote education through various programs and activities that will educate individuals in areas such as public safety, public health, and positive social interactions. The Corporation's target goal will be to reach the general population.

#### **ARTICLE IV: RESTRICTIONS ON ACTIVITIES**

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in, or intervene in, any political campaign or candidacy for public office.

#### **ARTICLE V: MEMBERSHIP**

The Corporation shall be non-membership.

**ARTICLE VI: REGISTERED OFFICE AND AGENT**

Having been named as the registered agent and to accept service of process for the above stated corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.

**ARTICLE VII: BOARD OF DIRECTORS**

The Board of Directors shall consist of five (5) persons. The number may be increased or decreased from time to time by an amendment to the Corporation By-Laws. However, there shall never be less than three (3) persons on the Board of Directors. All members of the Board of Directors shall be selected as provided for in the Corporation By-Laws. No member of the Board of Directors will be entitled to or shall receive any compensation for participation on the board. Board members will be required to agree to all Conflict of Interest guidelines established by the corporation and noted in the By-laws.

#### **ARTICLE VIII: OFFICERS**

The officers of the Corporation shall be a President, Vice President, Secretary, Treasurer, Public Relations Officer, Marketing Representative and such other officers as may be provided by the By-Laws. No member of the Board of Directors will be entitled to or shall receive any compensation for participation on the board. Board members will be required to agree to all Conflict of Interest guidelines established by the corporation and noted in the By-Laws.

#### **ARTICLE IX: AMENDMENTS**

These Articles of Incorporation may be amended at any regular or special meeting of the Board of Directors by a majority vote of those present, provided that notice of the intent to submit amendments shall have been given as provided by the By-Laws.

#### **ARTICLE X: DISTRIBUTION OF ASSETS UPON DISSOLUTION**

The property of the Corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of the

Corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon dissolution or winding up of the Corporation its assets remaining after payment or provision for payment of all debts and liabilities of the Corporation shall be distributed to a not-for-profit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

### ARTICLE XI: INCORPORATOR

The incorporator of the Corporation is: Thomas Walker. IN WITNESS WHEREOF, I, Thomas Walker, President of THE THOMLIN EDUCATIONAL AND SOCIAL SOCIETY INCORPORATED, have affixed our signature thereto on October 21, 2008, to the Article of Incorporation.
