ARTICLE IX - MEMBERS: QUALIFICATION; ADMISSION; NO VOTING RIGHTS

- A. Generally. The Corporation shall be authorized to admit members with no limitation on the number of such members.
- B. Qualifications. Members shall be expected to provide aid, comfort and support to disadvantaged citizens suffering from homelessness, often accompanied by the debilitating effects of alcoholism and/or drug addiction. Such support may take any of a variety of forms, including, but not limited to legal aid, physical donations of time and labor, emotional support (fellowship/friendship) and/or financial support (direct or indirect donations of money, clothing, food, employment, rent, etc.).
- C. Admission. Members shall be admitted at the sole discretion of the Board of Directors. Potential members shall submit an application form listing their name, residential address, period of residency in Marion County (if a Marion County resident) and reason for seeking membership in Unity Place Housing. Past volunteer efforts on behalf of Unity Place Housing or similar charities and organizations will be considered favorably by the Board in evaluating potential members.

- D. <u>Volunteers; Grandfather Status</u>. To the extent permitted by general law, volunteers who have been associated with Unity Place Housing for at least one year prior to the filing of these Articles shall be considered members of the Corporation and their annual membership fee shall not be due until April 15, 2015.
- E. <u>Annual Membership Fees</u>. Members shall be required to pay an annual membership fee (dues) of \$10.00 as of the date of filing of these Articles of Amendment. The Board may adjust the annual membership fee upwards or downwards, from time to time, by a majority vote of the Board, without the need to further amend the Articles. New members shall pay their membership fees at the time they are admitted as members. Old members shall pay their membership fees no later than April 15th of each calendar year.
- F. <u>No Voting Rights</u>. Members shall have no voting rights and no right to control the Corporation or bind it for any purpose. All voting rights and the right to bind and control the Corporation shall be retained by the Board of Directions.
- G. Removal of Members. Members may be removed from the Corporation by any of the following means:
 - (1) Written resignation of the member;
 - (2) Failure to pay the annual membership fee when due;
- (3) By vote of a majority of the Board of Directors, at the sole discretion of the Board, at any time and for any reason.
