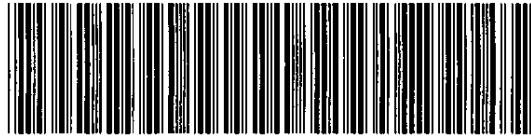

**AMENDMENT TO ARTICLE EIGHT  
DISTRIBUTION OF ASSETS UPON DISSOLUTION**

In the event that the Pensacola Bay Baptist Association, a 501(c)(3), no longer exists upon the dissolution of the organization, assets shall be distributed to the Florida Baptist Convention so long as such organization is organized and operated exclusively for charitable, educational, religious, or scientific purposes and at that time qualifies as an exempt organization under Section 501(c)(3) of the Internal Revenue Code. In the event that the Florida Baptist Convention, a 501(c)(3), no longer exists upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
