(Attach additional pages if necessary) (continued) **Articles of Incorporation of** the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation Law of *Florida*, do hereby certify:

- I. The name of the Corporation shall be <u>Keep My Child Corporation</u>.
- II. The place in the state where the principal office of the Corporation is to be located is the City of *Homestead*, *Miami Dade* County.
- III. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. This organization was put together to help individuals with children recognize and learn to manage difficult situations they may encounter with regards to their children. This organization was also put together to equip children with the confidence needed to speak out to the caring adult about what they feel is a difficult situation for them. Ultimately, this organization was put together to keep families together while aiding to minimize the number of children being removed from homes.
