ARTICLES OF INCORPORATION OF FIRST COAST CONTRACTORS FOR CHANGE INC.

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I NAME

- 4. To plan, organize and provide leadership in the process of educating local minority contractors pursuing local contractual bids on the proper procedures and methods to be employed to acquire successful acquisition of state and local public contracts.
- 5. The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of ant future Internal Revenue Law.

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors the assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. "However" if the named recipient is not in existence or no longer qualified as a distribute, or unwilling to accept the distribution, the assets of the organization will be distributed to a fund, foundation, or organization which is organized and operated exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE V LIMITATION OF POWERS

Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE VI DIRECTORS

The initial Board of Directors will be appointed by the initial incorporators.

ARTICLE VII BYLAWS

The bylaws will be formulated and implemented by the Board of Directors once appointed by the initial incorporators.
