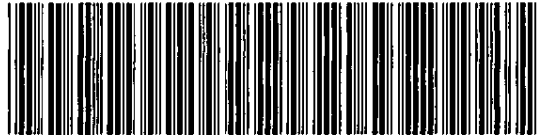

ARTICLES OF INCORPORATION
OF
FIRST COAST CONTRACTORS FOR CHANGE INC.

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be:

FIRST COAST CONTRACTORS FOR CHANGE INC.

ARTICLE II
PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address shall be:

ARTICLE III
PURPOSES

1. To serve as a positive stimulus developing a community based support relationship targeting socially and economically disadvantaged persons domiciled within greater Jacksonville, Duval County, Florida and the surrounding areas.
2. To formulate, development and implement apprentice programs in the areas of plumbing, trucking, landscaping and lawn maintenance and others vital careers areas that lead to professional licensing individual entrepreneurial ventures.
3. To serve as an information network monitoring the formulation and implementation of state and local policies that regulate minority business enterprise.

4. To plan, organize and provide leadership in the process of educating local minority contractors pursuing local contractual bids on the proper procedures and methods to be employed to acquire successful acquisition of state and local public contracts.
5. The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of ant future Internal Revenue Law.

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors the assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. "However" if the named recipient is not in existence or no longer qualified as a distribute, or unwilling to accept the distribution, the assets of the organization will be distributed to a fund, foundation, or organization which is organized and operated exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE V LIMITATION OF POWERS

Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE VI DIRECTORS

The initial Board of Directors will be appointed by the initial incorporators.

ARTICLE VII
BYLAWS




The bylaws will be formulated and implemented by the Board of Directors once appointed by the initial incorporators.

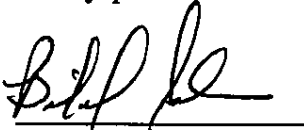
