#### ARTICLES OF INCORPORATION

OF

#### CITIZENS FOR ANIMAL RIGHTS & EDUCATION, INC.

### ARTICLE I

The name of the not-for-profit Corporation is Citizens for Animal Rights & Education, Inc. (the "Corporation").

### ARTICLE II ADDRESS

The mailing and street address of the principal office of the Corporation shall be 912 Shipwatch Drive East, Jacksonville, Florida 32225.

### ARTICLE III REGISTERED AGENT AND OFFICE

The initial registered office of the Corporation shall be 912 Shipwatch Drive East, Jacksonville, Florida 32225, and its initial registered agent at such office shall be Jose Horn.

### PURPOSE, POWERS AND RIGHTS

The Corporation is organized to cosme the proper treatment and care of animals. The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tex code.

### ARTICLE V PROPER DISTRIBUTIONS

No part of the net earning of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from a federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under

Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tex code.

#### ARTICLE VI DIRECTORS

Members of the Board of Directors shall be elected as provided in the Bylaws of the Corporation. The number of members of the Board of Directors may be increased or diminished from time to time as provided by the Bylaws; provided, however, there shall never be less than three. #### ARTICLE VII DISSOLUTION

Upon dissolution of the Corporation, essets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any finure federal tex code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent funisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as such Court shall determine, which are organized and operated exclusively for such purposes.
