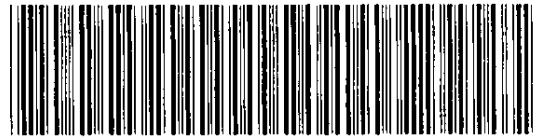

ARTICLE I

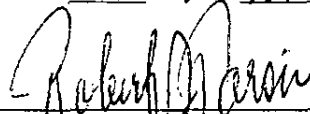
Name and Address

**FOURTH:** There are no members or members entitled to vote on the amendments. The amendments were adopted by the Board of Directors.

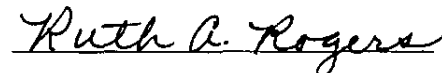
